## Release and Waiver of Liability and Assumption of Risk Agreement OptiMystics Citizens Action Network PO Box 101, Monte Vista, CO 81144

FOR GOOD AND VALUABLE CONSIDERATION, including permission to participate in the 2024 SoCo Suds & Sounds event and related activities, I, for myself, my successor, heirs, assigns, executors, and administrators.

- 1. Agree that prior to participation I will inspect the facilities, equipment, and areas to be used, and if I believe any of them to be unsafe, I will immediately advise persons supervising the event, activity, facilities, or areas.
- 2. Acknowledge that I fully understand that my participation may involve risk or serious injury or death, including economic losses which may result not only from my own actions, inactions, or negligence, but also from the actions, inactions, or negligence of others, the condition of the facilities, equipment, or areas where the event or activity is being conducted, the rules of conduct, or this type of event or activity.
- 3. Assume any and all risks of personal injuries to myself, including medical or hospital bills, permanent or partial disability, death, and damage to my property, caused by or arising from my participation in the event or activity.
- 4. Covenant not to sue or present any claim for personal injury, property damage, or wrongful death against the OptiMystics Citizens Action Network, the Poor Boy Car Club or the City of Monte Vista, their officers, employees, or agents, and agents attributable to my participation in the event or activity.

- 10. The OptiMystics, at their sole discretion, reserves the right to refuse a vendor's participation in our events, for any reason.

<u>Set Up:</u> Saturday, August 17, 8 AM until 10 AM. Beer vendors will be positioned around the pavilion in Chapman Park. Craft & Food vendors will be positioned around the beer vendors/pavilion. Please enter on the north side of the park, near the pavilion. We will guide everyone in and out of their spaces as quickly as possible. Please be careful not to drive over the sprinkler heads.

The Poor Boys Car Club will also be hosting their annual car show in conjunction with the festival; they will surround the park along the walking track. All entrants to the car show will enter on the north side of the park, near the playground. The car club will get you checked in. For more information, contact Richard Garcia at: 719-580-2673.

Show Time: Saturday, August 17 from 10 AM until 7 PM.

<u>Tear Down:</u> Saturday, August 17 from 7 PM until 8 PM. Please note that all booths must be torn down this evening and your area cleaned up.

<u>Vendors:</u> Please provide your own tables, chairs, awnings and power as needed. Electricity will not be provided in the park, please bring your own generator. All generators must be quiet running and not exceed a 60 dB noise level. In case of inclement weather, bring tarps & a way to hold your booth down.

<u>Confirmation:</u> A confirmation email will be sent after your forms and donation have been received. More information regarding the event your location, vendor ideas, etc will be provided in August, before the event.

Sales Tax: All vendors are responsible for self-reporting your own sales tax. 2024 Monte

Vista tax is: State=2.9%.

Rio Grande County=2.6%. Monte Vista City=3%.

Total=8.5%
